## EQUINE FOSTER HOME AGREEMENT

This equine foster home agreement (the "Agreement") is made and entered into by and between Seeded Faith Farm Rescue (the "Rescue" or "owner"), and (Full Legal Name): \_\_\_\_\_ (the "Foster Parent").

*Responsibilities of the Foster Parent: The Foster Parent agrees to the following terms and conditions:*

- Provide the Equine with proper care and attention, including feeding, watering, grooming, exercise, and medical treatment as needed.
  - Follow any specific instructions or requirements provided by Seeded Faith Farm Rescue.
  - Comply with all local laws and regulations regarding the care and ownership of animals.
    - Notify Seeded Faith Farm Rescue if the Equine becomes lost or stolen.
  - Notify Seeded Faith Farm Rescue if the Equine's health or behavior changes significantly.

*Expenses: The Foster Parent agrees to be responsible for all expenses related to the Equine's care, including but not limited to food, medical treatment, grooming, and supplies.*

*Ownership and Custody: Seeded Faith Farm Rescue retains ownership of the Equine, and the Foster Parent has no ownership rights. The Foster Parent agrees to accept custody of the Equine and to be solely responsible for the Equine's care and actions from the date of this Agreement.*

*Termination: This Agreement may be terminated by Seeded Faith Farm Rescue if the Foster Parent fails to fulfill their responsibilities under this Agreement, or if the Equine's needs are no longer being met. In the event of termination, the Foster Parent agrees to return the Equine to Seeded Faith Farm Rescue within 1-7 days.*

*Once the equine is fully rehabbed and ready to be placed in their permanent home they will be placed up for adoption. Foster parent has first option in choosing to adopt the fostered equine, should foster parent chose not to adopt the equine other potential adopters have the chance to view, decide, and/or adopt the equine.*

*This Agreement constitutes the entire understanding of the parties concerning the subject matter hereof, and supersedes all prior and contemporaneous agreements and understandings, whether oral or written. This Agreement may not be amended or modified except in writing signed by both parties.*

*The Foster Parent agrees to assume full responsibility for the animal, including any and all liabilities or damages that may arise as a result of the animal's actions or behavior. The Foster Parent shall indemnify and hold the rescue organization (Seeded Faith Farm Rescue) and its employees, agents, and volunteers harmless from any and all claims, damages, or expenses arising out of or in connection with the animal's actions or behavior. This indemnification obligation shall survive the termination of this Equine Foster Home Agreement.*

*This Agreement and any disputes arising out of or in connection with it shall be governed by and construed in accordance with the laws of the state of Michigan, without giving effect to any principles of conflicts of law. The parties agree to submit to the exclusive jurisdiction of the courts of the state of Michigan for the resolution of any disputes under this contract.*
